Policy background: It is the largest wetland of importance for nature conservation in

the European Union. The resident population is relatively low, but increases considerably in the high season with tourists, who make a substantial contribution to the regional economy. The national authorities of the three countries have been cooperating actively since 1978 on the protection of this exceptional area, in particular within the framework of the

Trilateral Conference.

### 2. Collaboration & integration

Objectives re collaboration & integration:

The Wadden Sea project involves all of the counties bordering the Wadden Sea. The rationale behind this decision was that planning initiatives should stem from this regional (county) level and should be participatory in nature, but that they also need to be co-ordinated between the regions in the trans-national context of the Wadden Sea and the Tri-lateral Wadden Sea Co-operation. The interregional Wadden Sea Co-operation (IRWC) complements the existing Trilateral Co-operation between the three Governments, which seeks to harmonise policies, laws and management measures to achieve the common purpose of sustainable use of coastal areas and resources.

segment.

### 6. Progress & Continuity

Follow-up Activities:

NetForum has written a report on Sustainable Tourism Development in the Wadden Sea region (April 2000), in which ICZM is analysed and policies are recommended by NetForum. Both will be discussed at the ninth Conference on the Wadden Sea in 2001. In this report it says that NetForum will initiate, coordinate and facilitate the follow-up activities in a further participatory process with the stakeholders. The NetForum suggests that the Inter-regional Wadden Sea Co-operation, as first step, adopt an action plan which should entail the following elements:

Implementation of the suggested policies of NetForum: How, by Whom and When. Implementation of the priority projects including their funding and the setting up of an adequate organisation for the implementation and co-ordination of the projects. Monitoring of the activities. The action plan should take into account cross-thematic activities and should therefore embody approaches such as the following:

Tourism development should be more oriented towards target groups; Communication and Co-operation strategy for the local level; Network designed for the technical support and counseling of the partners in the Wadden Sea Region with regard to the implementation of environmental measures in the tourism sector; Development of demand oriented and competitive solutions and the Making use of public-private-partnetship (PPP).

At the ninth Conference on the Wadden Sea in October 2001, there is an opportunity for all people to discuss the suggestions and proposals done by NetForum.
