La Gironde is seeking to elaborate solutions for problems identified in the Schèmas de Mise en Valeur de la Mer (SMVM) drafted in 1993 which has no associated action plan. The SMVM are zoning plans for areas of sea and adjacent coast, adopted by the State on the submission of the Prefet du Departement, after consultation with local authorities and interests.
